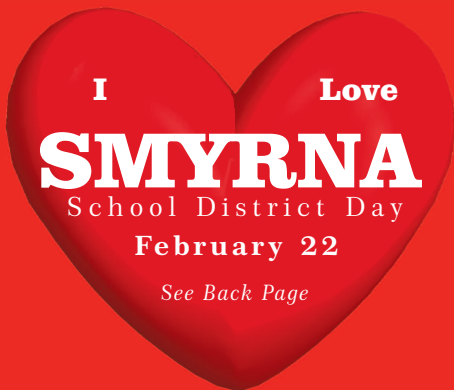

## From the Superintendent's Desk...

*Winter Message from Deborah D. Wicks*

I am writing this article to thank you for the support you have given our community's children in their educational journey in the Smyrna School District. Your attendance at school district events including concerts, plays, award ceremonies, holiday luncheons, open houses, PTO meetings, and sporting events has been exceptional.

More than any other school district, I believe our community stands up for their children in every way possible. With this backing, an outstanding staff, and a carefully formed curriculum, the Smyrna School District and each of the eight schools individually have once again met all of the Department of Education's state goals (A.Y.P. Annual Yearly Progress). Presently, we are celebrating this accomplishment with banners for each building. We also recognized that this wonderful community effort is not new but started 130 years ago with the first graduating class of 1885 with just seven students.

As you know the Smyrna School District has been growing since our last operat-

ing referendum was approved in 2004. During these ten years we have all witnessed our student population grow from 3,310 to 5,235 a 58% increase. To meet this increasing enrollment growth our community supported a doubling of district capacity. During all of these projects we have been fiscally prudent. (See page 9.)

With the blessing of our School Board and with the recent school shootings on our minds, the District contracted with Fearn and Clendaniel Architects to do a building needs assessment that identified necessary repairs at five buildings that focused on maintaining the integrity of each building and life, health, and safety issues. We applied for and were granted a Certificate of Necessity from the state of Delaware. The state agreed with our plan and will pay 67% of the projects' cost if we pass a referendum for the local share of 33%. (See the details on page 9.)

In order to continue to operate all of these wonderful facilities and to continue to manage the many outstanding classes and

programs, we have been very dependent on state of Delaware funds. Our state funding has been slowly dropping since 2008 with the yearly loss in 2013 totaling \$1,289,552. (See page 9 for more information.) Consequently, the Smyrna School District will not be able to maintain its existing program offerings and build upon current success without an increase in local funds to replace the loss of state revenues. The cost of this proposed increase in current expense and in debt service (major capital improvements) tax rates will be less than \$10.00 per month for the average tax payer. The Smyrna School District will still have the fourth lowest total tax rate in the state!

We will need everyone's support and positive vote for our students' future on Saturday, February 22, 2014, to back this much needed referendum. (See polling places and times on back page.) Our students' safety and educational goals are dependent on our Community's support. Once again, thank you all for being a blessing to our school family.

## MODEL OF RESPONSIBILITY: U.S. REPRESENTATIVE JOHN CARNEY

The Smyrna School District is proud to announce that this year's role model of responsibility is United States Congressman John Carney, a strong advocate for public education. Responsibility as defined by our 1999 community committee means "being reliable and following through on commitments. This includes being responsible for your actions as a family member, teacher, student, and citizen. You can demonstrate your responsibility through service to others and self-control."

Congressman Carney has been a faithful participant honoring our student winners in our annual Essay Contest on "I Love the Smyrna School District" day for 15 years.

Throughout his career, the Congressman has worked with both parties to find solutions to complicated issues. Since taking office, he has sponsored numerous bills to help create

jobs, reduce the deficit and grow the economy. He is a strong proponent of the "Make it In America" agenda, a Democratic initiative that aims to rebuild the U.S. manufacturing sector and create jobs in America by supporting small businesses, investing in infrastructure, and implementing smart tax policy and regulations.

John Carney's remarkable career has spanned more than 20 years. He has served as Secretary of Finance and Deputy Chief of Staff under then-Governor Tom Carper. He was twice elected Lieutenant Governor of Delaware where he implemented the Models of Excellence in Education program, which enabled successful schools to effectively share best practices with other schools around the state, raising test scores and producing better students. He led the fight for a Cancer Right to know Law, passed in 2008.

### Clayton Physical Education

We have been having lots of fun in physical education the first half of the year! The 3<sup>rd</sup> and 4<sup>th</sup> grade students started out the year with a unit on lacrosse. We practiced cradling, passing, offense, and defense. Then the students completed the state mandated Fitnessgram testing which tests the different components of fitness. Each child received an individual report of how well he/she scored in each area of fitness. We will repeat the test in the spring to see if the scores improve. The 1<sup>st</sup> and 2<sup>nd</sup> grade students learned their locomotor skills at the beginning of the year and then moved on to activities that helped make their heart and muscles stronger. We worked on finding our pulse and our resting and working heart rates. Kindergarten has primarily been focused on learning how to move safely in general space and chasing, fleeing, and dodging. Before the holidays, all the students worked on Speedstacking. Speedstacks is a great sport that helps students develop hand-eye coordination, ambidexterity, and hand speed. In January, we will be starting the New Year with basketball and jump rope units.



This Fall all of the students got to try out our brand new Heart Adventure Obstacle Course. We were able to purchase this obstacle course with money I received in a Wal-Mart grant. The course shows students how blood travels through the body and heart in a fun and exciting way. The students absolutely loved it and learned a lot! We will definitely be doing it again sometime later in the year. As the weather starts to get colder, please encourage your child to still exercise outside or in the house. If children are dressed appropriately, there is no reason why they can't get outdoors in the winter and exercise! We are excited about our upcoming winter activities! We will be having a Polar Express pajama day, where the students will complete activities that coincide with the story. ### Kindergarten Events

### The Human Body

During the first marking period our third graders learned all about the human body. We

began studying how the human skeleton provides our body with support, protection, and allows us to move and groove. Students learned the placement of the bones by building a small model of the skeleton here at school. After that, they were able to get creative by making their own replicas at home using materials of their choice. Some projects made us very hungry because we saw anything from candy to pretzels to pasta! Other students decided to let out their nature enthusiast side by using materials found outside like grass, pine cones, and rocks. And still others used everyday items around the house like nuts and bolts, beads, buttons, pipe cleaners, and Q-Tips (not used we hope).



After studying about bones, our students learned about the importance of our joints. Without them we would be as stiff as boards! Students experienced what it would be like to have unarticulated hands. It

sure was funny to watch them attempt to tie shoes, color, and open/close things with immobilized fingers! I think we all learned the gift of being able to bend during those experiments!

We rounded out our unit learning about the muscles, tendons, and ligaments. Students were able to build small models to simulate how the muscles of an arm, leg, and thumb work. During this Science kit our students became experts on the human body. They learned how the systems work together to help our bodies function day in and day out. So, if you asked one of our third graders, "Why did the skeleton go to the party alone?" Our boys and girls now know to say, "He had no BODY to go with!"

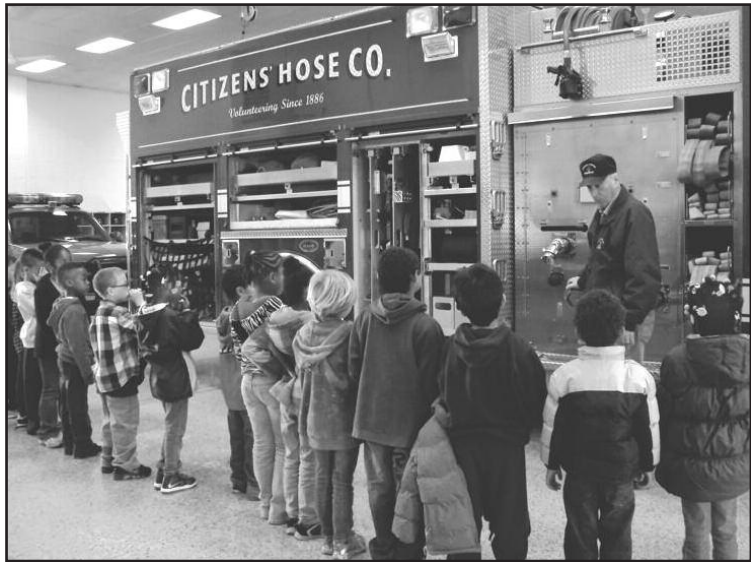
### Grade 4 Students Visit DuPont Environmental Center

### Health Benefits of Exercise "Stack Up" in World-Wide Event

The students at North Elementary participated in the "World's Largest Sport Stacking Event" on Thursday, November 14.

Sport stacking has been termed a "track meet for your hands at warp speed." It is an exciting sport where students up stack and down stack 12 specially designed cups called Speed Stacks in predetermined

sequences as fast as they can. Stackers race against the clock, compete in relays and often combine sport stacking with fitness challenges as part of physical education classes.

Last year, 483,658 stackers participated to break the previous year's STACK UP! record of 412,259. Once again, tens of thousands of stackers from across the

United States and around the world in countries such as Hungary, Germany, Israel, South Korea, New Zealand, Columbia and Taiwan contributed their sport stacking skills and helped set a new world record of 523,443. There are still schools that participated sending in verifications so that number will certainly rise.

September challenged students with the introduction of Wonders, the new reading series. Students must read analytically and apply skills and strategies in everything they read.

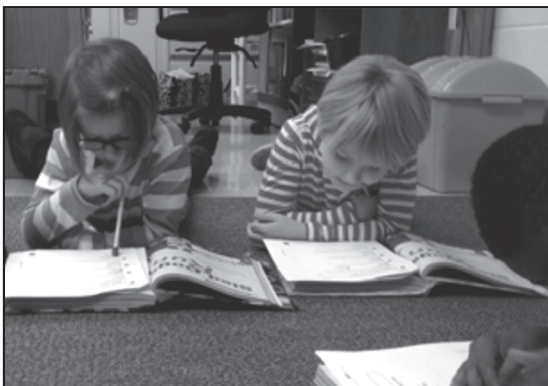
October's PBS reward was a hay-ride. Students enjoyed their ride around the grounds and a snack afterward.

## Sunnyside - Science and Engineering

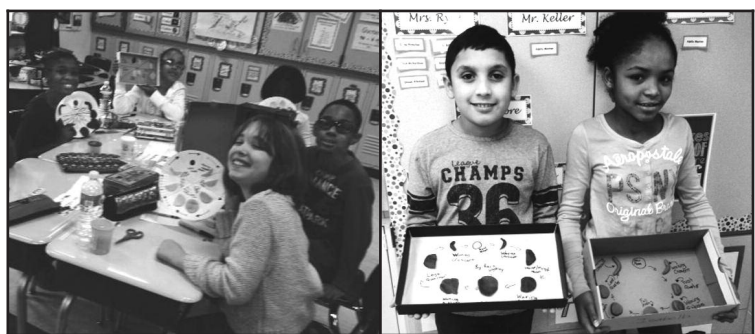

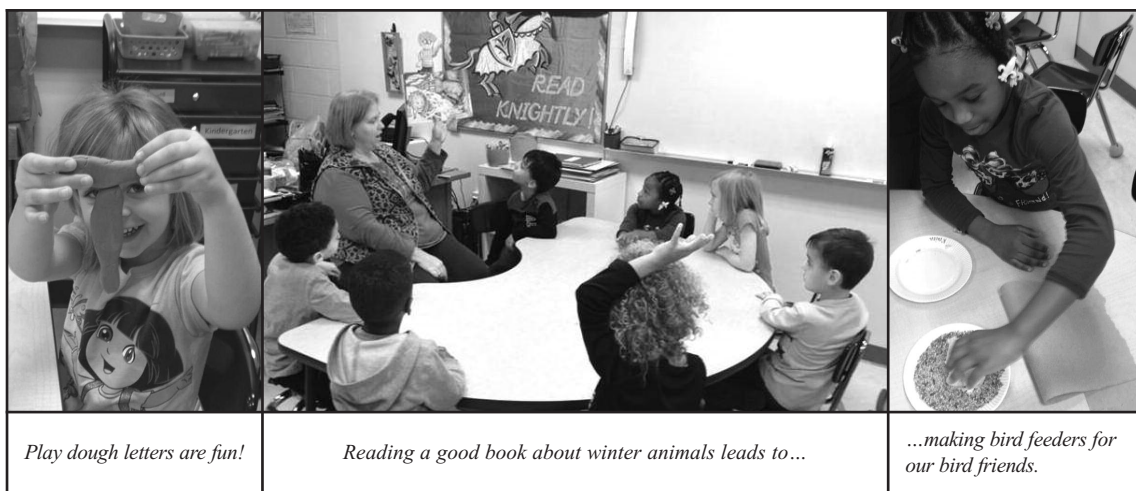

### Vocabulary Drives Deeper Understanding

The Words of the Week Program was implemented this year to give students exposure to academic vocabulary. A focus of the Common Core State Standards and the new-to-be-implemented Smarter Balanced assessment is the emphasis on academic vocabulary which drives a deeper depth and breadth of understanding content. Each week the school is introduced to a new vocabulary word and the definition of the word. The students are then challenged at lunch to use that word in different ways. For example, one week the challenge may require them to use the word in a poem revealing the true meaning of the word. Most challenges center on the use of a word in context providing the student and readers of the challenge a better understanding of the meaning and its uses. The challenges are placed in a box and a winner is chosen on Friday. The winning challenge is read over the announcements to the school as well. Students are very excited to participate in the "Word of the Week" challenges and there has been an abundance of student participation. In addition to challenges at lunch, the students are challenged to use these words in their writing, in their conversations with peers, and even identifying the words in text. Students are rewarded by receiving stickers on a "Word of the Week" chart. Once the chart is filled up, students are rewarded with monthly incentives.

## Words of the Week

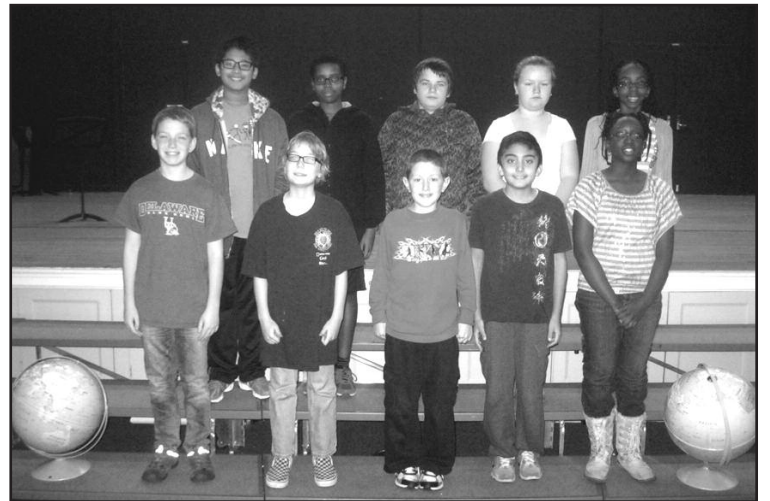

They also added a haunted hallway to the extravagan-

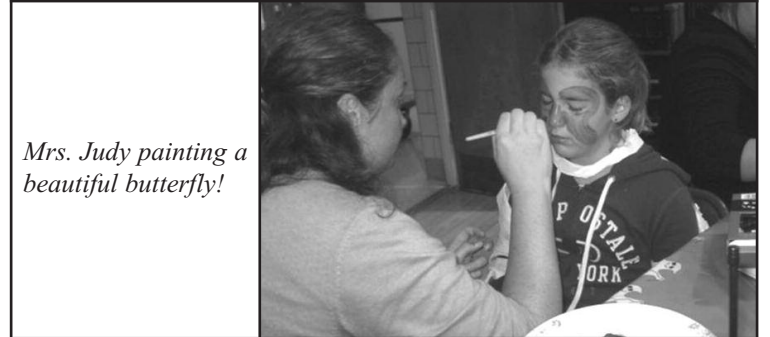

**Major Capital Improvement Referendum**

Authorization to issue bonds in the amount of \$4,854,400 for Major Capital Improvements. The bonds are to be financed through an increase in property taxes. The increase in annual local school taxes for the average property with a market value of \$200,000 is approximately \$6.99 in the first year, \$27.38 in the second year, \$26.59 in the third year with rates continuing to decrease over the next seventeen years.

The bonds represent 33% of the total cost of \$14,710,500 for the following projects.

**A: Smyrna Elementary School** - Renovations to include, but not limited to, accessibility issues, parking lot reconfiguration, toilet room modifications; cafeteria renovations and expansion; building system upgrades, safety and security systems, plumbing, electrical, mechanical upgrades, HVAC, building envelope, addition of sprinkler and fire alarm systems, and other upgrades.

**B: Clayton Elementary School** - Renovations and additions to include, but not limited to, building envelope issues; new sprinkler system and flooring upgrades; replacement of roof-top heating units; upgrading and replacement of duct work; replacement of air handling units; adding security cameras and card readers throughout the building.

**C: North Smyrna Elementary School** - Renovations and additions to include, but not limited to, addressing accessibility issues; sprinkler system; replace ceiling; plumbing and electrical upgrades; upgrades to fire alarm, telephone, and security systems.

**D: John Bassett Moore Intermediate School** - Renovations and additions to include, but not limited to, addressing building envelope issues; building entry modification for security and accessibility; security system upgrades; replace HVAC system and duct work; resurfacing and repainting tennis courts; replacing telephone system; and replacing generator.

**E: Thomas D. Clayton Building** - Renovations and additions to include, but not limited to, addressing building envelope issues; ceiling replacements; abandoned utilities; interior demolitions to construct new partitions; new mechanical systems; new plumbing systems; new electrical systems; sprinkler system; fire alarm and security systems.

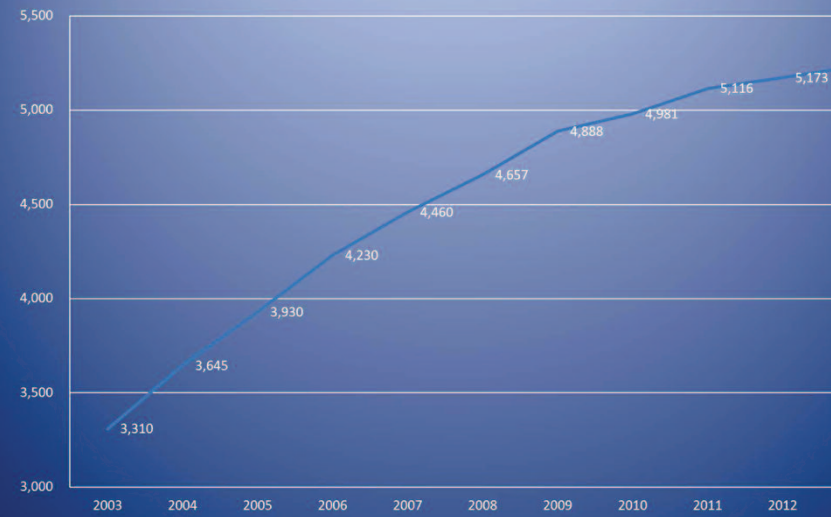

- The district has been fiscally prudent in its expansion and renovation projects.
- The renovation and expansion of Smyrna High was done under budget which allowed the district to make additional improvements to its HVAC systems and athletic facilities.
- The construction of Clayton Intermediate was also completed under budget which allowed for the addition of a solar array and upcoming critical repairs to roofing systems at three of our buildings.

**Facilities**

(Major Capital Improvement)

- The expansion of Smyrna Middle was completed under budget which allowed the district to renovate and expand the library at North Smyrna Elementary.
- Market conditions at the time of the Sunnyside Elementary construction (Hurricane Katrina) required additional state and local funding. The district utilized existing minor capital improvement funds and did not seek additional local funding.



## Facilities

(Major Capital Improvement)

- The district recently completed a building needs assessment that identified necessary repairs at five buildings that focused on maintaining the integrity of the building and life, health and safety issues.
- The district received a Certificate of Necessity (CN) from the state for these projects. See Major Capital Improvement on Sample Ballot on page 8.

## Operations Local Funding

- The district maintains a conservative fiscal approach and has demonstrated that it is a good steward of the tax funds it receives.
- The district has the third lowest total tax rate and the second lowest current expense rate in the state.
- The district had the second lowest revenue and expenditure per pupil amount in FY 2012.

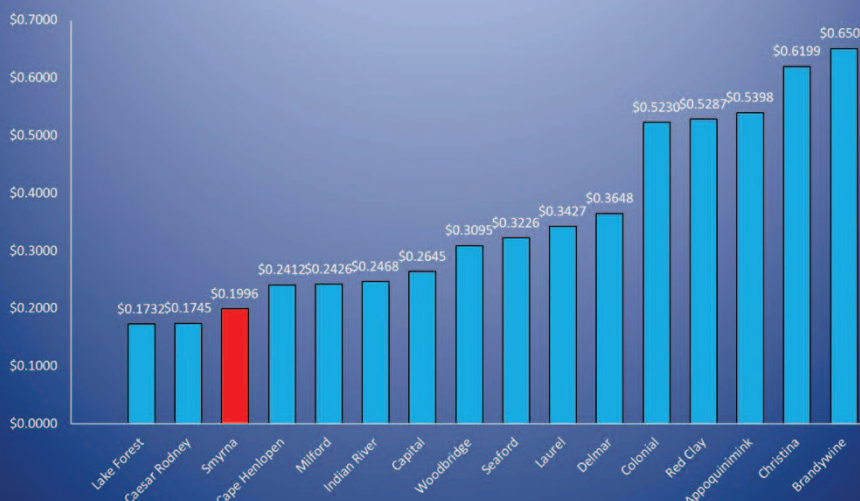

- The district is very reliant on state funding. In FY 12, average state share of revenue for all districts was 60.8% while Smyrna's state share was 78.9%.
- Between FY 2008 and FY 2013, the state share of district funding for operational programs dropped from \$34,311 to \$30,626 per unit.
- That equated to a loss of \$1,289,522 based on FY 2013 units.

- The district will not be able to maintain its existing program offerings and build upon current successes without an increase in local funds to replace the loss of state revenues.
- With the proposed increases in current expense and debt service tax rates, the district will still have the fourth lowest total tax rate in the state.

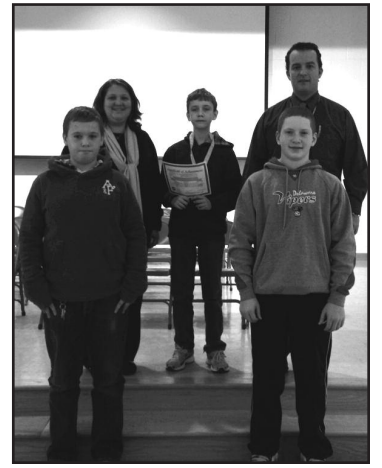

### DiRusso participates in prestigious World Food Prize Global Youth Institute

Des Moines, Iowa - Gabby DiRusso, of Smyrna High School, was among the top students in the country selected to attend the World Food Prize Global Youth Institute Oct. 17-19, 2013, in Des Moines, Iowa, during the Borlaug Dialogue International Symposium, which drew 1,500 people from more than 65 countries to discuss the world's hunger and food security issues. The World Food Prize was founded by Nobel Peace Prize Laureate Dr. Norman Borlaug in order to recognize and inspire great achievements in improving the quality, quantity and availability of food in the world. This year's World Food Prize events kicked off the beginning of a year-long anniversary celebration in honor of Dr. Borlaug's 100<sup>th</sup> birthday that will culminate in Fall 2014.

Students from across the United States and abroad researched global food security issues in the country of their choice, and then submitted papers on those critical topics, which they also presented to renowned experts and scientists.

At the three-day World Food Prize Global Youth Institute, DiRusso and 150 other high school students had the opportunity to interact with a diverse group of internationally renowned World Food Prize Laureates and leaders in food, agriculture and international development.

Global Youth Institute attendees participated in symposium sessions featuring: Ólafur Ragnar Grímsson, President of Iceland; Cardinal Peter K.A. Turkson of Ghana, President of the Pontifical Council for Justice and Peace, Holy See, The Vatican; Akinwumi A. Adesina, Honorable Minister of Agriculture and Rural Development, Nigeria; Former British Prime Minister Tony Blair, Howard G. Buffett and

Howard W. Buffett who announced the creation of the 40 Chances Fellows Program, a partnership of the Howard G. Buffett Foundation, Tony Blair's Africa Governance Initiative, and The World Food Prize; The CEOs of many of the world's major agribusiness companies: DuPont, Elanco, Kemin Industries, Monsanto, Novus International and Syngenta; and researchers, non-profit leaders and smallholder farmers from around the globe.

DiRusso presented a paper on the theme "Ending Hunger In Our Lifetime: A Call to Action" and participated in roundtable discussions with experts in industry, science, academia and policy. Research for the paper focused on major issues in global agriculture, development and food security in developing countries. Participants also helped with a hands-on service project packaging meals for Outreach International, a hunger-fighting organization that serves people in Iowa and abroad, toured an Iowa farm, and took part in an Oxfam Hunger Banquet to experience the realities of global hunger and poverty.

The students at CIS demonstrated compassion by raising over \$1,400.00 for the Ronald McDonald House in November.

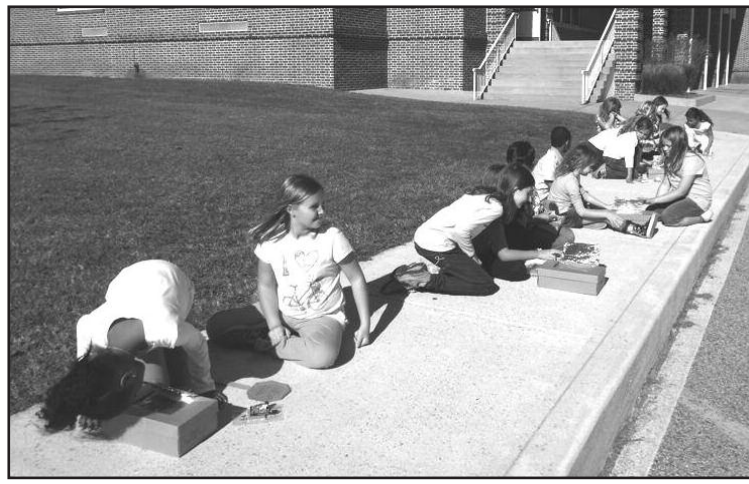

**NOTICE OF FERPA RIGHTS**

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age the following rights:

**Inspection**

You may inspect the student's education records within 45 days of the day the District receives a request for access. You should submit to the Principal a written request identifying the record(s) you wish to inspect. The Principal will notify you of the time and place of inspection.

**Amendment**

If you believe education records are inaccurate, you may request the records be amended. Such a request must be in writing, and directed to the Principal. The request must identify the part of the record you want changed, and specify why it is inaccurate. If the District denies your request, the District will notify you of the decision, advise of the right to a hearing, and provide the hearing procedures.

**Consent**

You have the right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without

consent. One exception permits disclosure without consent to school officials with legitimate educational interests. School officials include District employees, Board members, a person or company retained by the District to perform a special task (such as an attorney, auditor, medical consultant, or therapist), or a parent or student serving on a committee or assisting another school official. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

Upon request, the District will disclose education records without consent to officials of another district in which a student seeks or intends to enroll.

**Complaint**

You may file a complaint with the U.S. Department of Education concerning alleged failures by the District to comply with the requirements of FERPA. The name and address of the office that administers FERPA are:

the Global Youth Institute today receives major support from Clay Mathile and the Mathile Institute for the Advancement of Human Nutrition. The program was developed to challenge and inspire participating student-teacher teams to identify ways of alleviating hunger, and to expose the students to opportunities and careers in food, agriculture and natural resource disciplines.

At the Global Youth Institute, DiRusso interacted with students and teachers from Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Illinois, Indiana, Iowa, Kentucky, Louisiana, Massachusetts, Michigan, Minnesota, Nebraska, New Jersey, New York, Ohio, Pennsylvania, Tennessee, Texas, West Virginia, Wisconsin, and the U.S. Virgin Islands, as well as Bangladesh, China, Mexico, Nigeria, Turkey, and South Africa.

Participants also viewed the 2013 World Food Prize Laureate Award Ceremony that honored three individuals – Marc Van Montagu of Belgium, Mary-Dell Chilton and Robert Fraley of the United States – for their independent, individual breakthrough achievements in founding, developing, and applying modern agricultural biotechnology. Their research is making it possible for farmers to grow crops with: improved yields; resistance to insects and disease; and the ability to tolerate extreme variations in climate.

The calendar is based on legislation requiring students to attend school 440 hours (kindergarten), 1060 hours (grades K-11), and 1032 hours (grade 12) - with no minimum number of days. Any inclement weather days will be made up by staff immediately following the last teacher day.

## A PARENT'S RIGHT TO KNOW

Under the **No Child Left Behind Act** a parent has the right to know the following information:

- » The qualifications of the school staff providing instruction to their child.
- » Their child's level of achievement in each state academic assessment.
- » Whether their child has been assigned to or has been taught for four or more consecutive weeks by a teacher of a core academic subject who is not highly qualified.

Upon the parents request the school is to provide the following information:

- » Whether the teacher has met state qualifications and licensing criteria for the grade level and subject areas in which the teacher provides instruction.
- » Whether the teacher is teaching under emergency or other provisional status through which state qualification or licensing criteria have been waived.
- » The baccalaureate degree major of the teacher and any graduate certification or degree held by the teacher and the field of discipline of the certification or degree.
- » Whether the child is provided services by paraprofessionals and if so their qualifications.

The following letter will provide details on how parents may easily access information regarding their child's teacher(s).

Dear Parent:

As a parent of a student in the Smyrna School District you have the right to know the professional qualifications of the classroom teachers who instruct your child. Federal law allows you to ask

for certain information about your child's classroom teachers, and requires us to give you the information in a timely manner if you ask for it. Specifically, you have the right to ask for the following information about each of your child's classroom teachers:

- » Whether the Delaware Department of Education has licensed or qualified the teacher for the grades and subjects he or she teaches.
- » Whether the Delaware Department of Education has decided that the teacher can teach in a classroom without being licensed or qualified under state regulations because of special circumstances.
- » The teacher's college major; whether the teacher has any advanced degrees and, if so, the subject of the degrees.
- » Whether any teachers' aides or similar paraprofessionals provide Title I services to your child and, if they do, their qualifications.

A website has been setup for you to obtain this information at: <http://deeds.doe.k12.de.us> You may access this information by going to this website and click "Parents/General Public" on the left-hand side of your computer screen. Click "Search" for an employed Delaware public / charter school educator." Enter the last name of your child's teacher and click "search." Click the "profile" link after your child's teacher's name. You will find the teacher's certification under "credentials" and college major under "qualification."

If you are unable to obtain the necessary information, you may call you child's principal for this information, or our Personnel Office at (302) 653-8585.

#### 258 Federal Programs General Complaint Procedures\*

#### 1.0 Programs Covered by the Complaint Process

This complaint process shall apply to the following programs: Title I Part A Improving Basic Programs Operated by Local Education Agencies; Title I Part B-1 Reading First; Title I Part B-2 Early Reading First; Title I Part B-3 William F. Goodling Even Start Family Literacy Program; Title I Part C Education of Migratory Children; Title I Part D Prevention and Intervention Programs for Children and Youth Who are Neglected, Delinquent, or at Risk; Title I Part F Comprehensive School Reform; Title I Part G Advanced Placement; Title II Part A Teacher and Principal Training and Recruiting Fund, Grants to States; Title II Part A-5-2151(B) School Leadership; Title II Part D 1 and 2 Enhancing Education Through Technology; Title III Language Instruction for Limited English Proficient and Immigrant Students; Title IV Part A Safe and Drug Free Schools and Communities; Title IV Part B 21st Century Community Learning Centers; Title V Part A Innovative Programs and Title V Part B-1 Public Charter Schools.

#### 2.0 Right to File a Complaint

An organization or an individual may file a complaint regarding an alleged violation of Federal Program Statutes or regulations by the Delaware Department of Education or the Local Education Agency. For purposes of this regulation, a Local Education Agency shall also include charter schools. A written and signed complaint shall be filed with the Delaware Department of Education.

2.1 The complaint shall include a statement specifying the alleged violation by the State Education Agency or a Local Education Agency. Such statement shall include facts and documentation of the alleged violation.

2.2 The Delaware Department of Education shall investigate the complaint and issue a written report including findings of fact and a decision to the parties included in the complaint within sixty (60) working days of the receipt of the complaint. An extension of the time limit may be made by the Delaware Department of Education only if exceptional circumstances exist with respect to a particular complaint.

2.3 The Delaware Department of Education may conduct an independent onsite investigation of the complaint, if it is determined that an on site investigation is necessary.

2.4 The complaint shall allege a violation that occurred not more than one (1) year prior to the date that the complaint is received.

#### 3.0 Complaint Made to the Local Education Agency

An organization or an individual is encouraged to file a written, signed complaint with the Local Education Agency, prior to submission of the complaint to the Delaware Department of Education, concerning an alleged violation by the Local Education Agency of a Federal statute or regulation that applies to the Local Education Agency's program.

3.1 The complaint shall include a statement specifying the alleged violation by the Local Education Agency. Such statement shall include facts and documentation of the alleged violation.

3.2 The superintendent or the agency head of the Local Education Agency shall investigate the complaint and issue a written report including findings of fact and a decision to the parties involved in the complaint within sixty (60) working days of the receipt of the complaint,

3.3 An appeal of the Local Education Agency decision may be made by the complainant to the Delaware Department of Education. The appeal shall be in writing and signed by the individual or by an individual representative of the organization making the appeal. The Delaware Department of Education shall resolve the appeal in the same manner as a complaint, as indicated in 2.0.

#### 4.0 Review of Final Decision by the U.S. Department of Education

Any party to the complaint has the right to request that the Secretary, U. S. Department of Education, review the final decision of the Delaware Department of Education. The request for an appeal of the decision to the Secretary, U. S. Department of Education, shall be made in writing to the Delaware Department of Education within sixty days of the receipt of the decision.

### SMYRNA SCHOOL DISTRICT'S NOTICE OF RIGHTS UNDER THE PROTECTION OF PUPIL RIGHTS AMENDMENT (PPRA)

The Protection of Pupil Rights Amendment affords parents, students who are 18, and emancipated minors the following rights regarding the District's conduct of surveys, collection and use of information for marketing purposes, and certain physical exams.

**Protected Information Surveys**  
The District is required to obtain consent permitting your child to participate in certain school activities, or you may elect to opt out of such activities. These activities, known as protected information surveys, include a student survey, analysis, or evaluation concerning one or more of the following:

1. Political affiliations or beliefs of the student or student's parents;
2. Mental or psychological problems of the student or student's family;
3. Sexual behavior or attitudes;
4. Illegal, anti-social, self-incriminating, or demeaning behavior;
5. Critical appraisals of others with whom respondents have close family relationships;
6. Legally recognized privileged relationships, such as with lawyers, doctors, or ministers;

7. Religious practices, affiliations, or beliefs of the student or parents; or
8. Income, other than as required by law to determine program eligibility.

**Notice & Opportunity To Opt Out**  
At the start of each school year, the District will notify you of dates of the following activities, and provide an opportunity to opt a student out of participating in such activities:

1. Any protected information survey, regardless of funding source;
2. Any non-emergency, in-vasive physical exam or screening required as a condition of attendance, administered by the school or its agent, and not necessary to protect the immediate health and safety of a student, except for hearing, vision, or scoliosis screenings, or any physical exam or screening permitted or required under State law; and
3. Activities involving collection, disclosure, or use of personal information obtained from students for marketing, or to sell or

otherwise distribute the information to others.

Inspection

You may, upon request, inspect the following:

1. Protected information surveys of students;
2. Instruments used to collect personal information from students for marketing, sales, or other distribution purposes; and
3. Instructional materials used as part of the educational curriculum.

Adoption of Policy

The District will adopt policies, in consultation with parents, regarding these rights, as well as arrangements to protect student privacy in the administration of protected surveys and the collection, disclosure, or use of personal information for marketing, sales, or other distribution purposes. The District will notify you of these policies at least annually at the start of each school year and after any substantive changes.

**NONDISCRIMINATION ON THE BASIS OF SEX**

(Compliance Violation Grievance Procedure)

Any student or employee of the Smyrna School District shall have the right to file a formal complaint alleging noncompliance with regulations outlined in Title IX of the Education Amendments of 1972 or in

**Level One – Principal or immediate supervisor (informal)**

A student with a complaint of sex discrimination shall discuss it with the teacher, counselor, or principal.

**Level Two – Title IX Compliance Officer**

If the grievance is not resolved at level one and the student wishes to pursue the grievance, the student may formalize the grievance by filing a complaint in writing on a Compliance Violation Form, which can be obtained from the Title IX compliance officer. The complaint shall state the nature of the grievance and the remedy requested. The filing of the formal written complaint at Level Two must be within 21 days from the date of the event giving rise to the grievance, or from the date the grievant could reasonably become aware of such occurrence. The grievant may request that a meeting about the complaint be held with the Title IX compliance officer. A minor student may be accompanied at that meeting by a parent or guardian. The Title IX compliance officer shall investigate.

the complaint and attempt to resolve it. A written report from the compliance officer about action taken will be sent to the grievant with 21 days after receipt of the complaint.

**Level Three – Superintendent**

If the complaint is not resolved at Level Two, the grievant may proceed to Level Three by presenting a written appeal to the Superintendent within 15 days after the grievant received the report from the compliance officer. A decision will be rendered and conveyed to the grievant by the Superintendent or his/her designee within 15 days after receipt of written appeal.

**Level Four – Other agencies**

The grievant may file formal complaints with the Delaware Civil Rights Commission or other agencies available for mediation or rectification of affirmative action grievances, or may seek private counsel for complaints alleging discrimination.

Note: The District appoints compliance coordinators for Title IX, Title VII and for Section 504 of the Rehabilitation Act of 1973, as required by law. These compliance coordinators serve as grievance officers and are responsible for the District's efforts to comply with nondiscrimination requirements under Title IX, Title VII, and Section 504.
